- 访问就业 (H-2) 资格人员开始新工作时，需向辖区出入境外国人厅（事务所）申报。未工作人员在新单位（个人、机关、团体或企业）开始工作（被雇佣）的，办理就业开始申报；已工作人员换工作（被雇佣）到新单位（个人、机关、团体或企业）的，办理就业事实变更申报。

- Job-seeking activities are only permitted in the 39 industry types of simple labor in accordance with Article 23(1) of Enforcement Decree of the Immigration Act and the attached Table 1-2(29) (Employment not allowed except for the permitted types of industry).
- * Permitted types of Employment for H-2 status can be found on the HiKorea website(www.hikorea.go.kr).
- H-2 status holders who are initially employed for an individual/organization/entity or business are required to report Commencement of Work to a jurisdictional immigration (branch) office and must report any changes in employment if he/she has already been employed for an individual/organization/entity or business.
